### **GENERAL**

# ITEM NO. I - SPECIFICATIONS

1. SECTION 01 11 00 SUMMARY OF WORK

Paragraph 1.02 E.1 is amended to read: C-1-SS (Alt), C-7-SS (Alt), C-10-SS (Alt) shall be included in the base bid.

# ITEM NO. II - CLARIFICATIONS

# **RFI #1**

Question: Will the concrete coring noted on S101 "MTCAP Concrete Cores" be performed by the Third party Testing Agency (not under the Contractor)?

Answer: All preparation, containment, access, clean up, etc. is by Contractor. 3<sup>rd</sup> party testing agency will take the core.

Question: If so, are containment measures required for the bare concrete slab core locations to support their coring activities?

Answer: Refer to ICRA Matrix, Division 01 ICRA Specifications, Division 13 Hazardous Material Specifications and Hazardous Materials survey for containment requirements.

Question: Additionally, if applicable, would Third Party Testing Agency include necessary clean up of slurry from coring activities and removal of any hot materials resulting from the hot concrete coring?

Answer: Hazardous Materials abatement is by contractor and clean up shall comply with requirements of Division 01 ICRA Specifications and Division 13 Hazardous Materials Specifications.

### **RFI #2**

Question: Who will be responsible for Air Clearance testing/reporting after Abatement activities?

Answer: Per Division 13 Hazardous Material Specifications, Entek Consulting Group will conduct Hazardous Material Management Oversight, which includes final visual inspections and collection/analysis of air samples for Asbestos and related reporting. Contractor is responsible to perform Hazardous Materials Abatement, Hazardous Materials Management and Reporting in compliance with requirements of Division 13 Hazardous Materials Specifications.

Question: Please send photos of the sample locations noted below, as there wasn't enough time to walk through these locations during the November 4<sup>th</sup> site walk. C-4-SS, C-11-SS, C-12-SS, C-14-SS, C-17-SS, C-18-SS, and C-19-SS.
