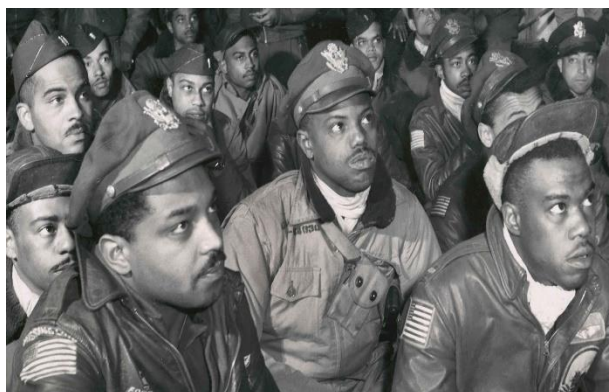


Black History Month

Black History Month is an annual celebration of achievements by African Americans and a time for recognizing their central role in U.S. history. Also known as African American History Month, the event grew out of "Negro History Week," the brainchild of noted historian Carter G. Woodson and other prominent African Americans. Since 1976, every U.S. president has officially designated the month of February as Black History Month. Other countries around the world, including Canada and the United Kingdom, also devote a month to celebrating Black history.



Origins of Black History Month

The story of Black History Month begins in 1915, half a century after the Thirteenth Amendment abolished slavery in the United States.

That September, Harvard-trained historian Carter G. Woodson and prominent minister Jesse E. Moorland founded the Association for the Study of Negro Life and History (ASNLH), an organization dedicated to researching and promoting achievements by Black Americans and other peoples of African descent.

Known today as the Association for the Study of African American Life and History (ASALH), the group sponsored a national Negro History Week in 1926, choosing the second week of February to coincide with the birthdays of Abraham Lincoln and Frederick Douglass. The event inspired schools and communities nationwide to organize local celebrations, establish history clubs and host performances and lectures.

In the decades that followed, mayors of cities across the country began issuing yearly proclamations recognizing "Negro History Week." By the late 1960s, thanks in part to the Civil Rights Movement and a growing awareness of Black identity, "Negro History Week" had evolved into Black History Month on many college campuses.

President Gerald Ford officially recognized Black History Month in 1976, calling upon the public to "seize the opportunity to honor the too-often neglected accomplishments of Black Americans in every area of endeavor throughout our history."

Today, Black History Month is a time to honor the contributions and legacy of African Americans across U.S. history and society—from activists and civil rights pioneers such as Harriet Tubman, Sojourner Truth, Marcus Garvey, Martin Luther King Jr., Malcolm X and Rosa Parks to leaders in industry, politics, science, culture and more.

The Black History Month 2026 theme, "A Century of Black History Commemorations," focuses on a century of national commemorations of Black history.

In one such case, a Guatemalan asylum seeker's testimony was mistranslated by an uncertified interpreter, leading to a wrongful deportation order. The decision was only reversed after legal advocates intervened and identified substantial interpretation errors.

These cases demonstrate the devastating impact of inadequate interpretation and the urgent need for trained professionals.

The Lunar New Year falls on February 17, 2026. It coincides with the date of new moon and signals the start of the Year of the Horse. One of 12 animal symbols of the Chinese zodiac (Rat, Ox, Tiger, Rabbit, Dragon, Snake, Horse, Goat, Monkey, Rooster, Dog and Pig) represents each year of the Chinese lunar calendar.

The horse was the most frequent transport means in ancient society, and it is considered as No. 1 of the most important 6 animals in China. They are strong, powerful and elegant animals. In Chinese culture, horses are always the representative of heroes and talents. People born in the Year of the Horse will share some similarities with the horse and thus they are brave, strong, talented, and independent. The Five Elements of Horse is Fire (Huo), symbolizing enthusiasm and energy, which entitles the Horse people energetic and enthusiastic character.

Historically, the Lunar New Year signals the arrival of *the world's largest annual human migration*. From the first day of the Lunar New Year (the day of the new moon) to the 15th day (next full moon), Lunar New Year celebrations abound. In the days that follow, celebrations include a variety of festivities. For example, there are dance parades featuring colorful dragons or lions. Or there are ceremonies to pay homage to deities and ancestors. Plus, children receive money in red envelopes and gifts are exchanged. Extended family members travel long distances to visit each other. What's more, each day holds a special significance that varies according to local traditions.
