

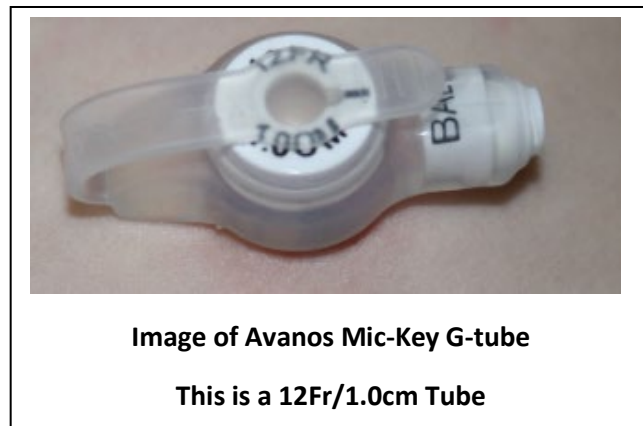
Feeding DME Job Aid

G-tubes:

Both the Avanos Mic-Key and the AMT Mini-One are low profile balloon retention gastrostomy tubes. They function the same but require different DME extension sets. While similar, they look a little different. If you're unsure which tube your patient has, use these images for clarification.

The Avanos Mic-Key is the most common low-profile Gtube used for UCD Children's Hospital Patients.

The corresponding order set for this tube is: **G-Tube Feeds- Chose G-Tube Type: Avanos Mic-Key Low Profile**



The AMT Mini-One is an alternative G-tube type that is less commonly used. The corresponding order set for this tube is: **G-Tube Feeds- Chose G-Tube Type: AMT Mini One**



GJ-tubes:

Both the Avanos Mic-Key and the AMT Micro G Jet are low profile balloon retention GJ tubes. They function the same but require different DME extension sets. While similar, they look a little different. If you're unsure which tube your patient has, use these images for clarification. The Avanos MIC tube is not a low profile tube and is not Enfit.

The Avanos Mic-Key is the most common low-profile GJ tube used for UCD Children's Hospital Patients. The AMT Micro G Jet and the MIC Tube 16 fr tubes are used less often and typically in smaller infants and children.

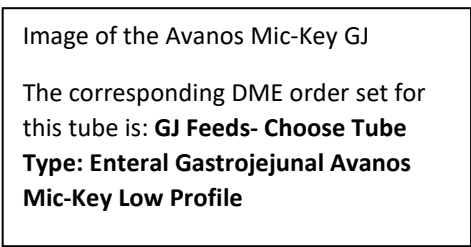




Image of the AMT Micro G Jet
