

# **Acute Care Clinical Services**

Provide care to adult patients on medical and surgical units throughout the hospital including general medicine, hospital medicine, women's health, family medicine, neurology, surgical and orthopedic trauma, neurosurgery and more. Our pharmacists hold board certifications in multiple specialties and provide representation on various committees such as UC Transition of Care Collaborative, Pharmacy Research Oversight Committee, Clinical Practice Council, Pain and Sedation Committee, NPMS, Falls, and NICHE. In support of health system initiatives, the Internal Medicine and Surgery Pharmacists provide support to nurses and providers, verify medication orders, manage comprehensive medication monitoring, participate in multidisciplinary care & discharge rounds, complete patient education for high profile anticoagulation medications, and expanded coverage of discharge medication reconciliations. Precepting pharmacy students and PGY1 and PGY2 residents remains an integral component to upholding UC Davis Health academic excellence.





# Infectious Disease (ID)

ID pharmacists provide patients with personalized, optimal medication therapy with respect to pharmacokinetics, pharmacodynamics, spectrum of activity, feasibility, evidence-based medicine, and cost. The ID team also serves as advisors and educators to the health system's pharmacists, physicians, other multidisciplinary healthcare professionals, and learners. They provide focused educational experiences to pharmacy interns, PGY1 & PGY2 pharmacy residents, including PGY2 residents specializing in ID. The team's pharmacists maintain stringent control over the antimicrobial formulary, review new agents, create, and update ID- related institutional guidelines and policies.

# **Behavioral Health (BH)**

Since the initiation of the Behavioral Health Pharmacy team in August 2021, the team has expanded patient care services in both acute and ambulatory care settings. Board certified psychiatric pharmacists collaborate closely with interdisciplinary psychiatry teams to tailor treatment plans and optimize medication regimens, resulting in improved patient outcomes.

# **Inpatient Oncology**

The Inpatient oncology team consists of 8 clinical pharmacists, including 7 Board-Certified Oncology Pharmacists (BCOPs). Additionally, the team comprises 8 pharmacy technicians and 4 Post-Graduate Year 2 (PGY2) oncology pharmacy residents. These dedicated professionals collaborate closely with other healthcare providers to ensure the optimal use of medications for patients receiving cancer treatment within the hospital, clinics, and infusion service areas.

The oncology team's responsibilities encompass a wide range of critical tasks. They actively participate in the development and maintenance of Computerized Physician Order Entry (CPOE) order sets specific to oncology. Furthermore, they rigorously evaluate new medications for potential inclusion in the hospital's formulary, a crucial aspect of ensuring the availability of cutting-edge treatments. In addition, the team plays a pivotal role in promoting guidelines aimed at promoting cost-effective and evidence-based cancer treatments.

Moreover, the oncology pharmacy team excels in the realm of medication management for cancer patients. Their expertise is instrumental in the safe and effective administration of medications vital to patients' well-being throughout the

course of their treatment.

# **Medication History**

The medication history team consists of 5 inpatient technicians and 6 Emergency Department technicians. The inpatient technicians focus on any and all patients admitted into the hospital while the ED technicians focus on the geriatric population in the ED. UC Davis has the highest completion rate of UCs for medication histories upon admission, which allows our providers and pharmacists to make informed decisions faster for our patient population.



# **Infusion Pharmacy**

The infusion pharmacy is an integral part of the inter-professional teams providing care to adult and pediatric oncology patients at UCDH consisting of 21 clinical pharmacists and 13 technicians at the Cancer Center and Placer Center for Health. Not only do the clinical pharmacists work collaboratively with other health care providers to optimize drug therapy for patients undergoing cancer treatment in clinics and infusion services area, but the team also develops and maintains Beacon order sets, reviews new medications for formulary consideration, creates guidelines for cost-effective, evidence-based treatment, and facilitates medication management.

# **Opioid Stewardship**

The UCDH Opioid Stewardship Program (OSP) provides critical infrastructure for the hospital with a focus on reducing adverse events related to opioid use both during and post hospitalization. The OSP pharmacist has successfully enhanced strategies for surveillance of inpatient opioid orders, policy reviews and developments, facilitation of patient and provider education, and patient safety event assessments. Additionally, there is active participation on numerous multidisciplinary committees focused on pain management, substance use disorder, and opioid safety. This role will continue to provide efforts focused on creation of quality assurance reports, committee involvement, alignment of the Opioid Stewardship team with a physician champion, and prospective monitoring to ensure the program meets guidelines and recommendations from the variety of organizations focused on opioid safety.

Hospitals that received 'Sustained Improvement' have achieved a status of 'Superior Performance' for two consecutive years. # **Transplant Clinical Services**

The Solid Organ Transplant Team comprises of both inpatient & ambulatory care pharmacists that provide comprehensive medication management services for kidney, liver, and heart transplant patients. The team has continued to grow with the launch of the liver transplant program in July 2023 which outperformed previous projections with 37 liver transplants performed in the first year. Additionally, the living donor kidney program has grown 43% since last fiscal year.



# Diversion, Automation, Informatics, & Analytics

Our team is dedicated to using data and technology to enhance the medication use system. We remain committed to pioneering solutions that empower patient care and improve operational excellence by enhancing efficiency, accuracy, and data-driven decisions at UCDH.









# **Acute Care Operations**

The Acute Care Operations Pharmacy team is a fundamental component of the patient care we provide across the health system. We are comprised of Central Pharmacy Operations and Perioperative Services. Our team of ~90 pharmacy technicians and ~35 pharmacists service all inpatient areas, several mixed-use areas (OR & procedural areas), and Pyxis stations in all ambulatory/outpatient clinics across the institution. We are a 24/7 pharmacy dispensing ~6 million doses annually with an annual budget of > ~\$100M.



### **Pumps Remediation**

A system-wide pump remediation of 3000+ BD Alaris devices was conducted to ensure an equal number of devices were swapped 1:1.

>99% completion over the course of 1 month



### **Operational Optimizations**

- Stockout: Occurrences of out-of-stock medications has decreased from 0.78% → 0.51%!
- Turnaround Time: Significant improvements in our efficiency of medication delivery, from time of order:

<u>CIVA</u>: 176 min → **65 min** (63% decrease) CUDA: 180 min → **97 min** (54% decrease)

PLX CUDA: 162 min → **65 min** (40% decrease)

 Nonsterile Dispense Prep / Dispense Check Dashboard Implementation:

The percentage of barcode scanning completed per week has **improved** from 98.6% → **99.1%**!



### **ASHP Grant**

UCDH received **\$30,000** from the ASHP Foundation for medication use systems research through the Enhancing Adoption of Radio-Frequency Identification (RFID) Technology Grant Program. RFID technology provides the potential to enhance medication safety, allowing our teams to devote more time to patient care.

# Perioperative Services (OR) Pharmacy Team

The Perioperative Pharmacy team currently includes 9 pharmacists and 8 technicians. The perioperative space operates as a mixed-use area servicing inpatients and outpatients. The OR team is responsible for covering the Main Hospital OR areas, ambulatory surgery centers, Pre-Op Clinic (PAC Clinic) and various procedural areas which can provide services to more than 250 patients on a normal operating day.

### FY24 Major Accomplishments:

- The OR Pharmacy team successfully launched a new CII Safe at the Same Day Surgery Center in collaboration with the Drug Diversion team.
- The OR team started an APPE rotation for UCSF students with three students precepted in the first year.
- Ongoing efforts are underway to prepare for the opening of a new, licensed OR Pharmacy at 48x in July 2025. The new area will include a sterile compounding suite and expand the OR Pharmacy team by 13 team members.

### **Advanced Prep Implementation:**

- Enhancing OR efficiency and patient safety by implementing Epic Advanced Prep tools and shifting medication compounding from inside of the OR into pharmacy-run spaces.
- Launched a new order set with Burn Surgery in October 2023 and implemented waste-reduction modifications in January 2024.



# **Retail Pharmacy Services**

Retail pharmacies provide traditional outpatient pharmacy services to patients and employees, including screening prescriptions for appropriateness, insurance billing, dispensing, and providing consultation to patients and staff.

We operate five locations, including two locations that dispense specialty drugs, across the hospital campus in Sacramento and in Davis. We strive to meet the needs of our customers by providing exceptional service and ensuring the safe use of medications to provide the best possible patient outcomes.

- Pavilion Pharmacy: 173,660 (+1.6%): Only pharmacy in the main hospital, serving discharge and ED patients 7 days a week
- ACC Pharmacy: 68,567 (+23%): Serving primary care and specialty clinics, and Same Day Surgery

# 340B Program

This federal program, guided by Health Resources and Services Administration (HRSA) and the Office of Pharmacy Affairs (OPA), requires drug manufacturers to provide discounted medication to entities who provide services to a disproportionate share of the underserved population.

The primary goal is to ensure continuous compliance, while maximizing savings and opportunities to ensure that UC Davis Health meets the intent of this important program: to stretch scarce federal resources as far as possible, reaching more eligible patients and providing more comprehensive services.

# 340B Program Highlight

Manufacturers have restricted 340B pricing at contract pharmacies, impacting overall savings. To mitigate the risk, we implemented an 'Alternative Distribution Model' with the help of Health Solutions Pharmacy to recover lost savings.

# **Key Highlights of FY24:**

### **Transition to Shared Services Center**

Successfully closed Cypress Pharmacy and opened Health Solutions Pharmacy at the new Shared Services Center, where all staff from the hub and dispensing are now united in one location, fostering a more cohesive and communicative team, improving efficiency and collaboration.

### **Home Delivery Program Expansion**

Expanded our home delivery program, enhancing convenience for patients by providing direct access to medications at home, serving a total of 4,460 patients and delivering 45,895 prescriptions.

### **Specialty Pharmacy Expansion**

Expanded our specialty program across various clinics and therapies, working closely with providers to better support a larger patient base and offer more treatment options. This growth added 2,009 patients to our specialty program and increased prescription volume by 23,530.






